CALL TO ORDER

Chairman Bobbie Jones called the meeting of the Upper Coastal Plain Council of Governments Board of Directors to order at 6:40 p.m. He welcomed all in attendance and thanked them for taking the time to attend. He introduced special guests in attendance. Roll was called and attendance was duly noted.

PUBLIC HEARING

Chairman Jones called for a Motion to open the public hearing. A Motion was made by Ms. Martha Lucas and seconded by Ms. Sherry Lucas. All voted in favor and the Motion carried. Chairman Jones then called for comments from the general public regarding the Fiscal Year 2024 – 2025 budget. There being no comments, Chairman Jones called for a Motion to close the public hearing. The Motion was made by Ms. Delane Bryant and seconded by Ms. Barbara Simmons. All voted in favor, the Motion carried, and the public hearing was closed. Next, Chairman Jones called for a Motion to adopt the Fiscal Year 2024 – 2025 budget. A Motion was made by Mr. Gregory Browning and seconded by Jenny Hinnant. All voted in favor and the Motion carried.

APPROVAL OF CONSENT AGENDA

Chairman Jones called for a Motion to approve the Consent Agenda items which included the FY 2023 – 2024 financial reports, budget amendments, FY2024 – 2025 Board meeting schedule and the meeting minutes of the May 21, 2024 meeting. A Motion was made Ms. Martha Lucas and seconded by Ms. Barbara Simmons. All voted in favor. The Motion carried and the consent agenda was approved.

CHAIRMAN'S REPORT

Chairman Jones thanked the Board for allowing him to serve as the Chairman for the last two years. He also reported that Mr. Hiett had received an outstanding evaluation from the Executive Committee and commended him on a job well done.

NOMINATING COMMITTEE REPORT – Gregory Browning, Nominating Committee Chair

NCARCOG UPDATE

He reported that he is very proud of the progress that is being made.

ACTION ITEMS

<u>Annual Program of Work – Robert Hiett, Executive Director</u>

Mr. Hiett reported that the FY 2024 – FY2025 Program of Work continues with a theme of identifying regional issues and opportunities and outlines a series of actions to address them. The UCPCOG will continue to work to coordinate broadband/digital literacy planning activities, support continued expansion into housing grants to assist our local governments, explore clean energy grant opportunities, continue to explore opportunities for transit coordination, provide targeted technical assistance, grant writing and grant administration, and explore innovative ways to implement aging and workforce services. He outlined the highlights of the FY 2023 – FY 2024 accomplishments and the recommended Program of Work goals.

Each program director then briefly covered the highlights of their FY2024 Program of Work accomplishments and their FY2025 recommended Program of Work, which were included in the agenda packet.

EXECUTIVE DIRECTOR'S REPORT – Robert Hiett, Executive Director

Mr. Hiett called the Board's attention to his report beginning on Page 75 of the agenda packet. He stated that due to the short time span between the May and June meetings, his report would be brief. He discussed the preparation for the Workforce financial monitoring and the results of the Aging compliance review. There were no issues found.

PRESENTATION OF PLAQUE

Incoming Chair Mayor Boykin presented the outgoing Chair, Bobbie Jones, with a plaque in appreciation of his years of service as our chairman.
